Request for Proposal (RFP) for the provision of medical health insurance cover for pact Zambia for the period of one (1) year from Insurance Companies.

A. Introduction

Pact is an International NGO with offices throughout the world with a mission to enable systematic solutions that allow those who are poor and marginalized to earn a dignified living, be healthy and take part in the benefits that nature provides. Pact accomplishes this by strengthening local capacity, forging effective governance systems and transforming markets into a force for development.

Pact Zambia is working with five other NGO partners is implementing the Zambia Integrated HIV and Health activity. Zambia Integrated Health is a five-year (2023-2028), USAID-funded mechanism with the goal of improving health outcomes of Zambians through equitable access to high-quality health services in the areas of client- centered HIV, Tuberculosis; Maternal; Newborn and Child Health, Family Planning and Reproductive Health.

Integrated Health will reduce mortality, morbidity, and HIV transmission for sub-populations in Northwestern, Copperbelt, and Central Provinces.

Pact Zambia therefore requires purchasing of the service to provide medical health insurance cover for a period starting 15th November 2024 to 14th November 2025

Vendors must not submit zipped files. Those pages requiring original manual signatures should be scanned and sent in PDF format as an email attachment. - Quotes must contain a completed quote cover sheet (Attachment 1)
- Proposals submitted through hard copy will not be considered.
- Quotations received after that time or at a different address may not be accepted
- All quotations and delivery dates shall be valid for a period of at least thirty 30 days following the submission due date mentioned above.

D. Evaluation Criteria

Pact will award a contract resulting from this solicitation to the responsible vendor based on the following evaluation method:

- Best Value using the following evaluation criteria:
 - Best Price (Premium) 30%
 - Specifications of services/benefits provided 20%
 - o Past performance– 20%
 - On boarding period/commencement of cover from date of award-30%
